

Ordinance 3-2011
Alcoholic Beverages Licenses – Quotas & Fees

Lincoln Township, Wood County, State of Wisconsin ordinance establishing schedule of fees for alcohol related licenses and permits and follows:

TITLE AND PURPOSE – This ordinance is entitled the Town of Lincoln Alcohol-Related License Fees and Quotas. The purpose of this ordinance is to establish a schedule of the fees for all types of alcohol-related licenses issued by the town and to set the quota of licenses permitted in the Town of Lincoln.

AUTHORITY – The Town Board of the Town of Lincoln, Wood County, Wisconsin, has the specific authority under those specific sections of ch. 125, Wis. Stats., stated next to the name of the license or permit listed in the Schedule of Fees for Alcohol-Related Licenses set forth below to establish fees for alcohol-related licenses issued by the town and to set the quota of license distributed in the town..

ADOPTION OF ORDINANCE – This ordinance, adopted by a majority of the town board on roll call vote with a quorum present and voting and proper notice having been given, adopts the Schedule of Fees for Alcohol-Related Licenses set forth below and establishes the fees for alcohol-related licenses and by the town and to set the quota of license distributed in the town as stated therein.

SEVERABILITY – If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

EFFECTIVE DATE – This ordinance is effective on publication or posting.

The town clerk shall properly post or publish this ordinance as required under s. 60.80, Wis. Stats.

"Class A" intoxicating premise license (Liquor – retail)	s. <u>125.51</u> <u>(2) (d)</u>	Min \$50 & Max \$500 per year
